This memorandum of understanding is made on 18th June 2020 i.e., the MEAI Mumbai Chapter Foundation and first annual day

M/s MEAI Mumbai Chapter represented by the founder-chairman, **Mr Ravi Chandran Raj**, Address at D- 201 & 202; Neel Residency 02; Sector-3; New Panvel (E), Navi Mumbai - 410206
and

M/s Pillai College of Engineering (PCE), represented by the principal **Dr Sandeep Joshi**, Address at Dr K.M. Vasudevan Pillai Campus, New Panvel (E), Navi Mumbai 410206

The MEAI Skill Tech Centre would operate with following objectives and Terms of Association mutually agreed by both the parties.

1. MEAI Skill Tech Centre is formed and owned by MEAI Mumbai Chapter with the objectives to professionally grow MEAI Mumbai Chapter and provide technical training, workshops, mines safety and legal compliance, statutory training courses, and skill development to the members of MEAI and Mining Industry, Quarrying and other allied industries also to integrate with engineers and student member development.
2. The proposed MEAI Skill Tech Centre would operate in professional and administrative association with M/s Pillai College of Engineering (PCE) at their respective campus- Dr K.M. Vasudevan Pillai Campus, New Panvel (E), Navi Mumbai (410206)
3. The Centre would be headed by Dr Sandeep Joshi, Principal of Pillai College of Engineering with five members of MEAI Mumbai Chapter approved by the chairman of MEAI Mumbai Chapter.
4. MEAI Mumbai Chapter will also provide two or three technically qualified members to develop course material for technical training and workshops and also interact with mining industry stakeholders, mining industry professionals, quarry owners, equipment and accessories companies, government agencies

like Department of Mines and Geology, IBM, Peso, DGMS etc. to provide the training course or technical course materials approved by them to meet the objectives of MEAI Skill Tech Centre.

5. The MEAI Skill Tech Centre would also involve the students of PCE and students from any other Mining Institutes in live consulting, projects related to mining and infrastructure for practical orientation and case studies and encourage student members of MEAI to participate and present technical papers in technical conferences organised by MEAI Mumbai Chapter and other chapters of MEAI meeting the terms of participation. Such opportunities also would be provided to students and faculties of Pillai HOC College of Engineering and Technology (PHCET) and other relevant technical institutes promoted by M.E.S group.
6. The Pillai College of Engineering campus would display the board of MEAI Skill Tech Centre prominently in the college premises.
7. MEAI Skill Tech Centre will operate from **Pillai College of Engineering, New Panvel (E), Navi Mumbai (410206)**.
8. PCE will extend campus resources and facilities like auditorium and conference hall, workshop premises for the official conduct of MEAI Mumbai Chapter and MEAI Skill Tech Centre. However, MEAI Mumbai chapter will pay and use the Catering facilities for the requirement of breakfast, lunch, dinner, High Tea during the occasions of technical training, workshops, conferences etc.
9. PCE will have the privilege of organising campus placements through MEAI Mumbai Chapter by inviting MEAI Members, top professionals and corporate and industrial group members.
10. All legal and commercial compliance of MEAI Mumbai Chapter and MEAI Skill Tech Centre will have complied at the cost and responsibilities of MEAI Mumbai Chapter especially for tax filing, revenue, receipt and expenditure compliance etc. MEAI Mumbai Chapter would indemnify PCE, head of MEAI Skill Tech Centre and all other M.E.S. groups of institutes from any legal and commercial clients and responsibilities.



12. This Memorandum of Understanding is subjected to 180 days notice of termination if either one or both the parties willing to terminate the association



